Conference on Solving the Problem of New York State's Uninsured

The Problem:

Approximately 2.5 million New Yorkers lacked health insurance in 2007 according to estimates from the United Hospital Fund,¹ a New York City-based health policy center. According to the Manhattan Institute for Policy Research, "Today's health care markets have been constrained in many ways, for better and for worse, by the decisions of previous regulators, governors, and legislators. Gridlock in Washington over health care reform has thrust states back into their time-honored role as laboratories for new social problems."

Grant Activities & Outcomes:

This is the first of two grants to the Manhattan Institute from the New York State Health Foundation's Coverage Consortium initiative. By convening two conferences, health policy staff at the Manhattan Institute fostered debate and discussion about the role of market-based strategies to increase access to coverage.

Paul Howard, Ph.D., directed the project.

In 2006, the Center for Medical Progress at the Manhattan Institute issued a white paper entitled "Rx NY" that analyzed reform proposals under debate in New York and offered market-driven recommendations for reform.

Rx NY served as the background paper for the two conferences convened by the Institute in 2007–2008. The conferences featured presenters and panelists from a range of political perspectives and professional backgrounds. Other policymakers, advocates, and providers attended and offered observations and opinions.

Rx NY and the conference discussions set the stage for the second Consortium grant.² Under that grant, the Institute analyzed focus group, survey, and microsimulation results to formulate health coverage options available to people not covered through their employer.
